## WHAT IT TAKES TO BE PART OF THE PROGRAM

All applicants must fulfill the following criteria to be able to apply for the program.

### ELIGIBILITY CRITERIA

---

Applicants must have obtained at least 70% in their 12th (or equivalent).

---

Must have an IELTS score of 6.0 overall with no band less than 6.0 or equivalent, or TOEFL of overall 69 with writing not less than 21, or PTE of overall 50 with no individual band less than 50.

---

No prior refusal of any visa for Australia.

---

Must meet the GTE requirements as described by the Department of Home Affairs.

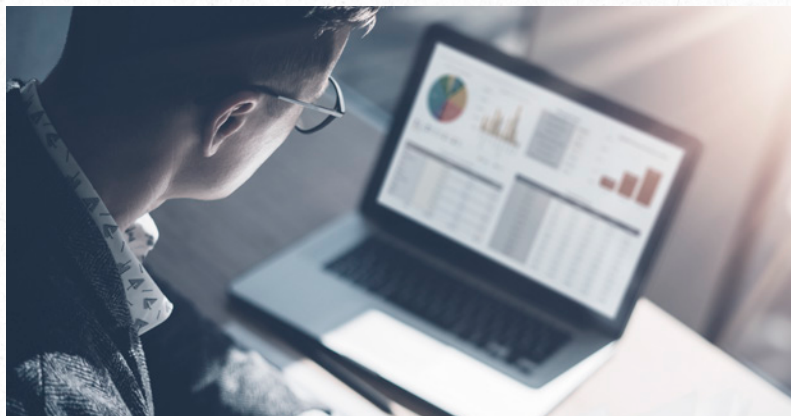

Students will be given a conditional offer upon meeting the above criteria.

---

Students need to secure a minimum weighted average mark of 60% in the first year at Great Lakes Institute of Management to proceed to Deakin University, Australia for Years 2 and 3.

## FINANCIAL REQUIREMENTS

1. Evidence of funds to cover tuition fees, 12 months living cost, and travel to Australia for the student as below:

Travel	Self	AUD 2000 (Return airfare to Australia)
Tuition	Self	Trimester Fee
Living	Self	AUD 21,041

2. Students should have access to funds. If only the tuition fee is being covered by an education loan, then at least the 1<sup>st</sup> semester fee must be disbursed and a loan disbursement letter is mandatory.
3. If the education loan covers both the tuition fee and the living expenses, then an adequate loan must be disbursed to take care of 1<sup>st</sup> semester fee and the living expenses for 6 months in Australia.





## GUIDELINES

1. Recent funds (deposits later than 3 months of review) will not be considered without a source.

---
2. Large recent deposits in the bank account must be supported with details of the source of funds.

---
3. Only FDs as evidence of funds are not acceptable. At least INR 5 Lakh (apart from the 1<sup>st</sup> semester fee) must be in the parent's or student's account and should be available for withdrawal as and when required.

---
4. Agricultural income: Individual  
INR 6.5 Lakhs | Parents - INR 8 Lakhs

---
5. 75% funding from parents and 25% from a 3rd party sponsor is preferred. Grandparents can sponsor up to 50% of the total funding.



## APPLICATION PROCESS

Submit the required documents



Clear the interview



Offer letter from the Great Lakes Institute of Management will be released. Upon payment of the blocking fees to GLIM, a conditional offer will be released from Deakin University stating that 'upon acquiring 60% in Year 1, the student will be eligible to travel to Deakin for Year 2 and Year 3
