Scholarships

Jindal Global Law School (JGLS) recognizes the fact that affording quality higher education in law may not be easy for many prospective students. The school is therefore committed to selecting students for a substantial number of scholarships and fee concessions in various forms, both on **merit** and **need basis**.

LSAT—India score and parental income-limit remains the main criterion to award scholarship at JGLS. 50% students who study at JGLS get some form of scholarships.

The various forms of scholarships include -

- Domicile Fee Concession for students from Haryana,
- O.P. Jindal Outstanding Merit Scholarships,
- Naveen Jindal Young Global Scholarships,
- Shallu Jindal Outstanding Women Scholarships and
- Savitri Jindal Studentships/Graduate Assistantships.

Scholarships O.P. Jindal Outstanding Merit Scholarships

The top five scorers of LSAT—India test who enroll in the following programs are awarded the O.P. Jindal Outstanding Merit Scholarship of Rs.1 lakh each—

- The three year LL.B. program
- Five year B.A./B.B.A. LL.B. (Hons.) program
- One year LL.M. program

Naveen Jindal Young Global Scholarships

This award is given on the basis of an independent selection process, which includes an assessment of the candidate's grades in her/his Bachelor's degree, extra-curricular achievements etc.

- One student from the five year B.A./B.B.A. LL.B. (Hons.) program will be given one year program fee
- One student from the three year LL.B. will be given one year program fee
- One student from the one year LL.M. programwill be awarded 50% of the program fee

Savitri Jindal Merit cum Means Fellowship

This fellowship is for outstanding students who may not otherwise be able to afford the full fees of the M. A. (DLB). Financial support will be offered in exchange of work.

Shallu Jindal Outstanding Women Scholarships

The aim of the scholarship is to nurture, encourage and support outstanding women to enter the field of law. The following students will be awarded 50% of one year program fee to each, on the basis of an independent selection process. Students who qualify under Haryana domicile category may be eligible for full or partial fee concession.

- Two students from the three year LL.B. program
- Two students from the five year B.A./B.B.A. LL.B. (Hons.) and
- Two students from the one year LL.M. program

Haryana Domicile

Meritorious Haryana domicile students qualify for fee concession to study at JSIA.Candidate applying for Haryana Domicile Fee Concession should produce a Haryana Resident Certificate signed by the District Magistrate/General Assistant to Deputy Commissioner or Sub-Divisional Officer (Civil) or Tehsildar of the District to which the candidates belong.

• Students from SC/ST/OBC categories as well as differently abled students are especially encouraged to apply for admissions and scholarships at JGU.
